




SN74LVC14A . . . RGY PACKAGE



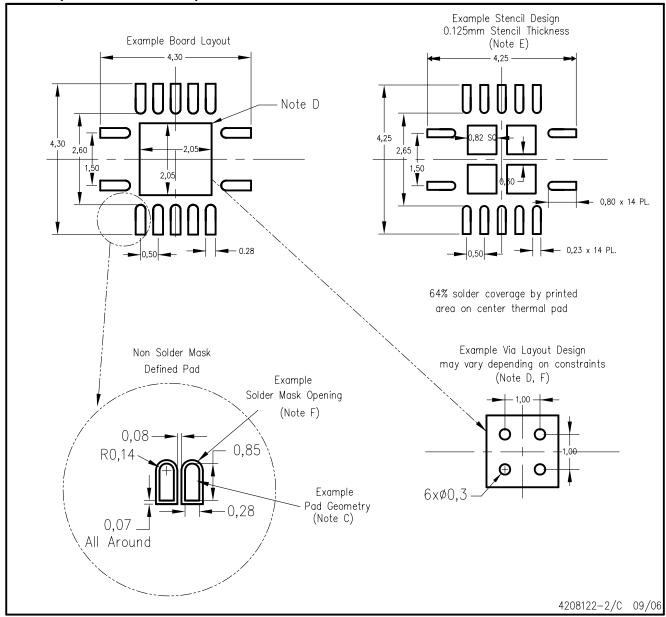
